




Installing the DRD/DQD LED Recessed Downlight / Make sure all power is turned off before beginning installation






Identify fixture location and use the included paper template to cut the mounting hole.






- Make wiring connections as follows:

 - c. Connect **Green** wire to ground wire




4 Tighten Romex connector clamp and close junction box.




6 Connect light engine. Be sure to properly align connectors and fully screw down connector cover.




Place driver box into ceiling.
